BOARDING AGREEMENT

1. I, the undersigned, certify that I am the owner of the above-named pet(s), or am acting as the owner's agent, and that the information I have provided about it is complete and accurate.
2. I hereby entrust said pet(s) to the care of the Animal Inn & Wellness Center, and agree to pay all charges for boarding and any other services deemed necessary for the animal's emotional and physical health while the animal is boarded at the Animal Inn & Wellness Center.
3. I understand and agree that although the Animal Inn & Wellness Center will attempt to meet specific requests, it cannot guarantee a particular enclosure or type of enclosure. The Animal Inn does guarantee that all animals will be boarded in an appropriate and healthful enclosure for the type, age, and size of animal. Animals not in the same family, or of different species, may not be boarded together.
4. I warrant that all required vaccinations and tests are current and agree to pay for any which are found to be overdue or which become due during the animal's stay at the Animal Inn & Wellness Center.
5. I agree to pay for all days reserved, regardless of whether I use them, unless I cancel with at least 72 hours' notice.
6. I agree to pay all costs for any personal injury to humans or damage to property caused by the animal's destructive or inappropriate behavior during its stay at the Animal Inn & Wellness Center.
7. I understand and agree that although every effort is made to maintain a healthful environment, animals in close quarters may transmit disease and/or parasites to one another. I also understand and agree that animals in the regular course of exercise and/or play may suffer injuries.
8. I agree to pay all veterinary charges incurred if animal becomes ill or injured during its stay. Every effort will be made to use the animal's preferred veterinarian, but if necessary, another may be used.
9. The Animal Inn & Wellness Center will exercise due and reasonable care to prevent injury or illness to the animal; but I agree that in the event of injury or illness, the owners and employees of the Animal Inn & Wellness Center will not be personally liable for such injury or illness; and that the liability of the Animal Inn & Wellness Center will not exceed the lesser of the current common value of a pet of the same breed, or \$200.
10. I understand and agree that all charges are due on the day the animal is picked up; any animal left more than 30 days beyond its estimated date of departure may transferred at the discretion of the Animal Inn & Wellness Center. Interest charges shall accrue on claims from the due date at a rate of 18% per annum. Animal Inn reserves the right to charge \$25.00 per day for a pet left beyond the scheduled departure date without prior consent by the Animal Inn & Wellness Center.
11. I understand and agree that this is a permanent contract, which will remain in effect for all stays of the pet(s) named above, until and unless canceled in writing by me or by the Animal Inn & Wellness Center. I have read the agreement and understand it. A copy will be provided by request.

Playtime Agreement

1. I further understand and agree that the Animal Inn & Wellness Animal Inn & Wellness Center may, at its discretion, exercise my dog with other dogs.
2. I understand that there are inherent risks and liabilities with playtime, such as the risk that dogs may fight, and I hold the Animal Inn & Wellness Animal Inn & Wellness Center harmless for any injury which might result during playtime.
3. I agree to pay all veterinary costs for any injury sustained by my pet during playtime.
